

# Meggitt Supplier Shipping Instructions

Rev. July 1, 2021

Any delivery terms not specified in a *Meggitt executed* supplier agreement shall be shipped as follows:

If you have **failed to meet the due date** of our order:

You must pay the cost of freight by shipping “prepaid” for domestic shipments, and DAP our designated consignee address, Incoterms 2020 for international shipments. Brokerage fees and duty will remain our responsibility as long as all appropriate documents are turned over to our designated broker in a timely and appropriate manner. Our designated broker is Expeditors International.

If you have **met the due date** of our order:

- Domestic shipments are to be sent “collect”, meaning Meggitt pays for the freight on our account.
  - All shipments equal to or less than 90kgs/200lbs. and which have no *single* package greater than 68kgs/150lbs or exceed 108 inches in length; or have a *combined* length and girth exceeding 165 inches, shall be shipped via the small package carrier named on our order, using our designated account number. If this information has not been supplied, it is your responsibility to contact us for this information prior to shipment.
  - All other domestic/regional shipments shall be shipped as follows:
    - UK/EU/Asia: Ship via the named carrier in our order. If this information has not been supplied, it is your responsibility to contact us for this information prior to shipment.
    - North America: Send all shipment details to [MeggittNA@CHRobinson.com](mailto:MeggittNA@CHRobinson.com), with your Meggitt buyer on copy.
  
- International shipments are to be sent FCA your facility, Incoterms 2020.
  - All shipments equal to or less than 181kgs/400lbs. and which have no *single* package greater than 68kgs/150lbs or exceed 108 inches in length; or have a *combined* length and girth exceeding 165 inches shall be shipped via the small package carrier named on our order, using our designated account number. If this information has not been supplied, it is your responsibility to contact us for this information prior to shipment.
  - All other domestic/regional shipments shall be shipped as follows:
    - Complete and send all required export paperwork and shipment details to [MeggittINTL@CHRobinson.com](mailto:MeggittINTL@CHRobinson.com), with your Meggitt buyer on copy.

- Allowable Service Levels:
  - Only domestic ground or international economy service is permitted. Any expedited service level, such as next day air or international express, must be approved by us, in writing, PRIOR to shipment.
  
- Hazardous/Dangerous Goods:
  - It is the supplier's responsibility to be aware of any goods considered Hazardous/Dangerous.
  - As such, it is your responsibility to properly package, label and prepare necessary documentation in accordance with federal and local laws and regulations.
  - Regardless of weight, at times Meggitt will prefer to ship as palletized freight on LTL or international shipments. You must review the shipping requirements with your Meggitt buyer prior to shipping.

**Warning:** Failure to comply with *any* of these shipping instructions may result in us taking a credit for the full cost of freight plus a reasonable processing fee.
