LINEAR VARIBLE DIFFERENTIAL TRANSFORMER (LVDT) Part No. C152774-1 consisting of a cast aluminium alloy enclosure, the enclosure cover is secured by 4 socket head cap screws. The LVDT sensor is fitted into the end wall of the enclosure. The equipment is rated at 7 Vac, 3000 Hz, 0.025A.

The LVDT is for use with Whittaker electric gas metering valve, the valve will provide an external earth facility.
